



January 2024

With the aim of fostering evidence-based decision-making, promoting good governance, and enhancing civic awareness, the National Policy Forum (NPF) was officially registered under the Companies Act on 25th January 2024 as a private entity under the sole ownership of Mr. Milan Jung Katuwal. At present, the company has a team of 5 members and 2 advisors with a community of 9 interns and over 2300 social media followers across all our platforms.

April 2024

1. Multi stakeholder Discussion on "Protecting Labour Rights and Promoting Safer Migration in Nepal".

Hosted by Democracy Media Network (DMN) Nepal on April 10, 2024, at Aranya Boutique Hotel in Naxal, Kathmandu, NPF served as a knowledge partner, contributing to drafting the recommendations arising from the discussions. The event featured Hon. DP Aryal, the then Minister of Labour, Employment, and Social Security, as the Chief Guest and Dr. Sameer Khatiwada, Senior Economist at the Asian Development Bank as the keynote speaker. Stakeholders from 24 organizations dedicated to the rights of migrant workers actively participated, sharing insights and experiences.

The discussion highlighted key challenges faced by migrant workers and proposed actionable solutions to address their concerns including ratification of International Convention on Rights of Migrant Workers and paving the way for collaborative advocacy and policy reform.



2. The NPF Delegation visited the Federation of Community Forestry Users Nepal (FECOFUN) and discussed policy reforms to improve utilization of forest goods to enhance living standards of community forest user groups.

FECOFUN oversees a forest area spanning 2,425,392 hectares and works with 23,026 user groups across Nepal, highlighting its pivotal role in community-driven forestry initiatives. Being mindful of this, Mr. Milan Jung Katuwal met with Mr. Thakur Bhandari, President of FECOFUN, to engage in meaningful discussions about sustainable forest management and community empowerment.

May 2024

1. Publication and submission of a comprehensive report with recommendations on the "Multi Stakeholder Discussion on Protecting Labour Rights and Promoting Safer Migration in Nepal" to the Ministry of Labour, Employment and Social Security.

A comprehensive proceeding <u>report</u> on the multi stakeholder discussion conducted in April 2024 was prepared by NPF which was submitted to the Minster DP. Aryal on 1st May 2024 on the occasion of International Labour Day.

Hon. Minister DP Aryal expressed his deep appreciation for the report, which encapsulated key takeaways from the event along with recommendations for various stakeholders. He affirmed his commitment to advancing these recommendations in collaboration with Dr. Gopal Krishna Siwakoti, emphasizing the importance of collective efforts to address the issues faced by migrant workers.



2. Co-hosted 'Lex-Fiesta' along with National Law College.

To commemorate this year's National Law Day, the National Policy Forum (NPF) proudly partnered with the Student Welfare Council of National Law College as an event collaborator for their annual signature program, "Lex Fiesta 2081."

This final segment highlighted the participants' strategic thinking and problem-solving expertise, making the event a resounding success.



June 2024

3-Day Webinar on Nepal and India: Bridging Legal Systems Through Comparative Education

As a joint initiative between Christ (Deemed to be) University, India, and the National Policy Forum (NPF), a 3-day certificate webinar was organized from 5th to 7th June 2024.

Esteemed speakers from Christ University, including Prof. Dr. Anto Sebastian, Prof. Sugan Shine, and Prof. Prabhpreet Singh, contributed to the sessions. The webinar received 120 registrations, with 84 participants from over 30 different colleges and universities attending across all three days. The program aimed to foster comparative studies in legal education, facilitate knowledge exchange, and explore opportunities in India for Nepali students.

Additionally, NPF also opened a call for its first cohort of interns on 16th June 2024.



July 2024

1. Signing of Memorandum of Understanding (MoU) with the SpeakUP Nepal.

NPF and SpeakUp Nepal jointly signed an MoU on 23rd June 2024 marking the inception of a shared journey for fostering evidence-based research and magnifying the concerns of Nepalese citizens on issues that matter most to them.

SpeakUp Nepal is a digital platform that empowers Nepalese citizens to voice their concerns on pressing issues. It champions the principles of transparency, inclusivity, and collaboration, providing an avenue for all individuals, irrespective of their background, to express their views while also aiming to simplify the process of creating and supporting petitions, sharing narratives and ideas, and fostering connections among those with shared passions.

With the above background, NPF and SpeakUp Nepal have set forth a shared vision for envisioning plans, dialogues and actions for national prosperity and nation-building. NPF and SpeakUp Nepal aim to foster institutional collaboration, enhancing the capacity of both organizations. Both organisations plan to facilitate a vibrant exchange of ideas, knowledge, and best practices. The joint efforts will bolster the impact of both entities in their respective domains. NPF and SpeakUp Nepal both are committed to working together on mutually agreed-upon goals and agendas. Furthermore, there are plans to share volunteers for events and activities of shared interest.



2. Meeting with the Minister of Education, Science and Technology Hon. Bidhya Bhattarai to discuss the issue of inflexibility in emergencies during board examinations.

A comprehensive report was made after this discussion which was published on 12th September 2024.

3. Meeting with the Minister of Health and Population of Nepal Hon. Pradip Poudel to discuss the need for reforms in the National Health Insurance Program (NHIP) and the organization's support to the Ministry and the Government of Nepal in policy research.

The discussion emphasized strengthening NHIP to enhance healthcare accessibility and affordability. NPF also offered its expertise in policy research to support the Ministry and the Government of Nepal in achieving these goals.

The meeting also delved into the current status of the National Health Insurance Program (NHIP) and the operational challenges faced by the National Health Insurance Board. Discussions focused on identifying strategies to expand insurance coverage, improve service delivery, and ensure equitable access to healthcare across Nepal. The NPF delegation highlighted the importance of collaborative efforts in addressing these gaps and advancing the program's efficiency and inclusivity.

A detailed report was made after this discussion which was published in January 2025.



August 2024

By empowering participants to counter misinformation, the webinar enhanced their ability to contribute meaningfully to informed public discourse.



September 2024

1. Publication and submission of a report on "Insensitive Board Exams and Evaluation Policies: Negative Impact on Students' Future" to the Ministry of Education, Science and Technology.

On 11th September 2024, NPF held a joint virtual meeting with the Hon. Bidya Bhattarai, Minister of Education, Science, and Technology (MoEST), alongside officials from the Center for Education and Human Resource Development (CEHRD). During this meeting, NPF presented its latest report titled "Insensitive Board Exams and Evaluation Policies: Negative Impact on Students' Future." The Honourable Minister expressed her optimism about the impact of the findings and recommendations presented by the NPF and acknowledged the significance of the report, stating that it would serve as evidence to establish the well-being of thousands of students. She committed to taking necessary actions, noting that she would do everything within her capacity to crystallize this into a policy across all educational levels in the country.

The <u>report</u> sheds light on a critical gap in Nepal's education system across all levels where students are forced to take exams despite medical emergencies, family crises, or mental health issues. With no provision for emergency rescheduling, students often face detrimental consequences, such as risking their health or losing an entire academic year. This lack of flexibility leaves many without support during their most vulnerable moments.

During this, NPF also initiated a <u>petition</u> on SpeakUp Nepal's platform to garner wide engagements from where 98 signatures were collected.

2. Third in-house webinar on "International Order and Conflict" by Prachanda Adhikari was held on 22nd September 2024.

On September 22, 2024, the National Policy Forum (NPF) hosted an enlightening in-house webinar on "International Relations and Affairs," led by Prachanda Adhikari, a Ph.D. candidate at the University of Mississippi. On January 19, 2025, the NPF delegation, represented by Ms. Sadichchha Silwal and Mr. Shaksham Shahi, held a joint meeting with the Chief Advisor to the Minister of Health and Population (MoHP) Dr. Raghu Raj Kaphle, along with the legal advisor to the Minister, Advocate Pramish Khanal. During the meeting, the delegation officially handed over the report titled "Addressing Challenges and Enhancing Nepal's Health Insurance Policy—2024."

NPF played an active role in collaborating with the Health Insurance Reform Task Force established by the Ministry of Health and Population (MoHP). The task force, comprising distinguished professionals such as Dr. Shambhu Acharya, Dr. Bhagwan Koirala, and Dr. Raghu Raj Kaphle, was formed to address critical challenges in Nepal's National Health Insurance Program (NHIP). Together, the task force and NPF worked diligently to analyze the existing health insurance framework, identify gaps, and propose actionable reforms.



The task force, with input from NPF, submitted its comprehensive report to the Prime Minister, highlighting key recommendations, including increasing the insurance coverage amount from the current NPR 3,00,000 to NPR 5,00,000. In response, the Prime Minister directed the Ministry to prepare a detailed action plan within seven days to implement these reforms.




Fig. 1: Engagement rate of NPF in LinkedIn from January 2024 till January 2025.




Fig 3: Accounts reached by NPF's Instagram account from October 2024 till January 2025.

With no costs spent on paid promotions and advertisements, from October 2024 to January 2025, NPF's Instagram account reached a total of 8,277 accounts, with a remarkable 94.3% being non-followers. This highlights the organization's strong ability to attract new audiences through engaging content while also emphasizing the need to strategically encourage these viewers to become followers for sustained growth and deeper engagement.
