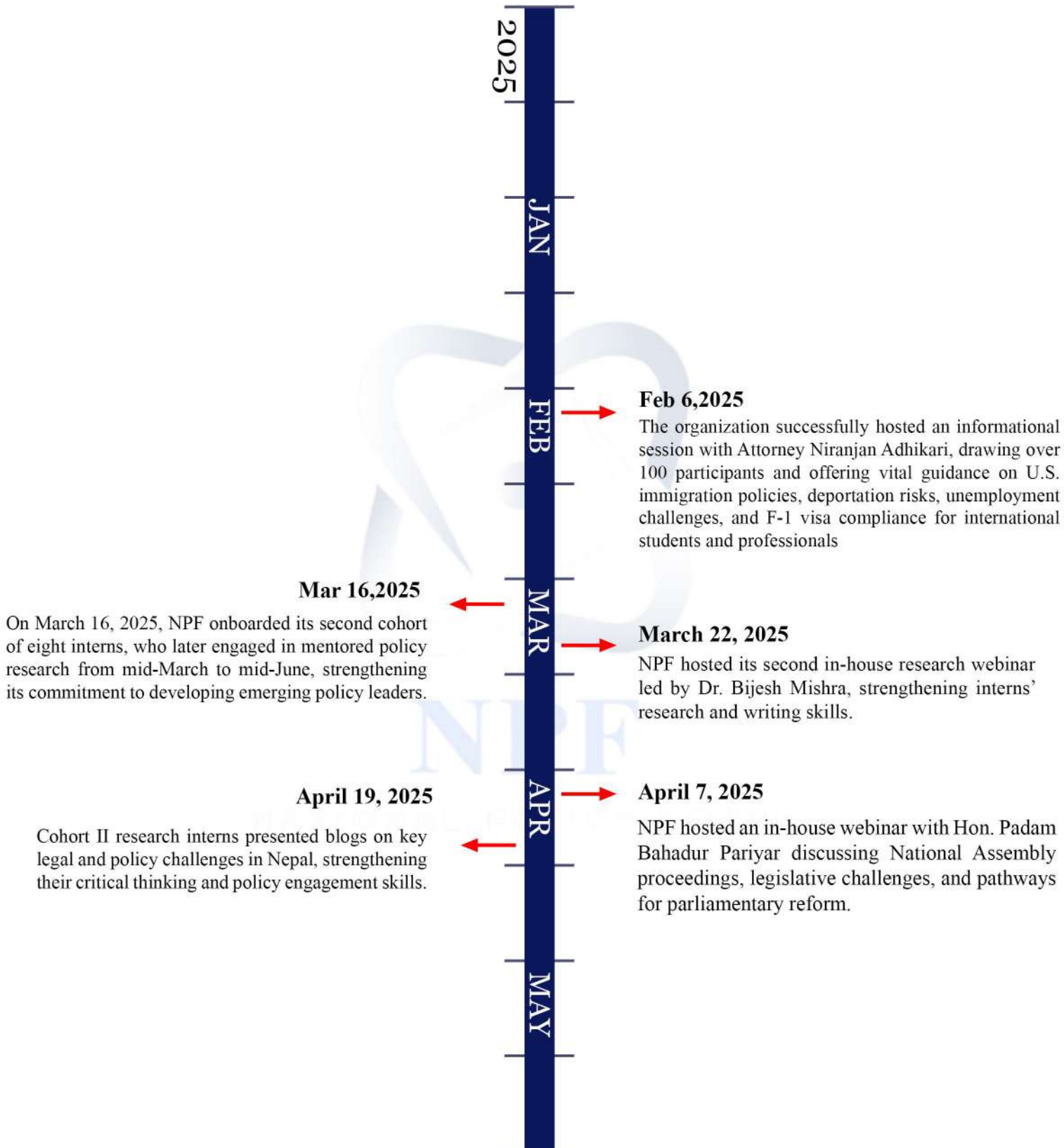

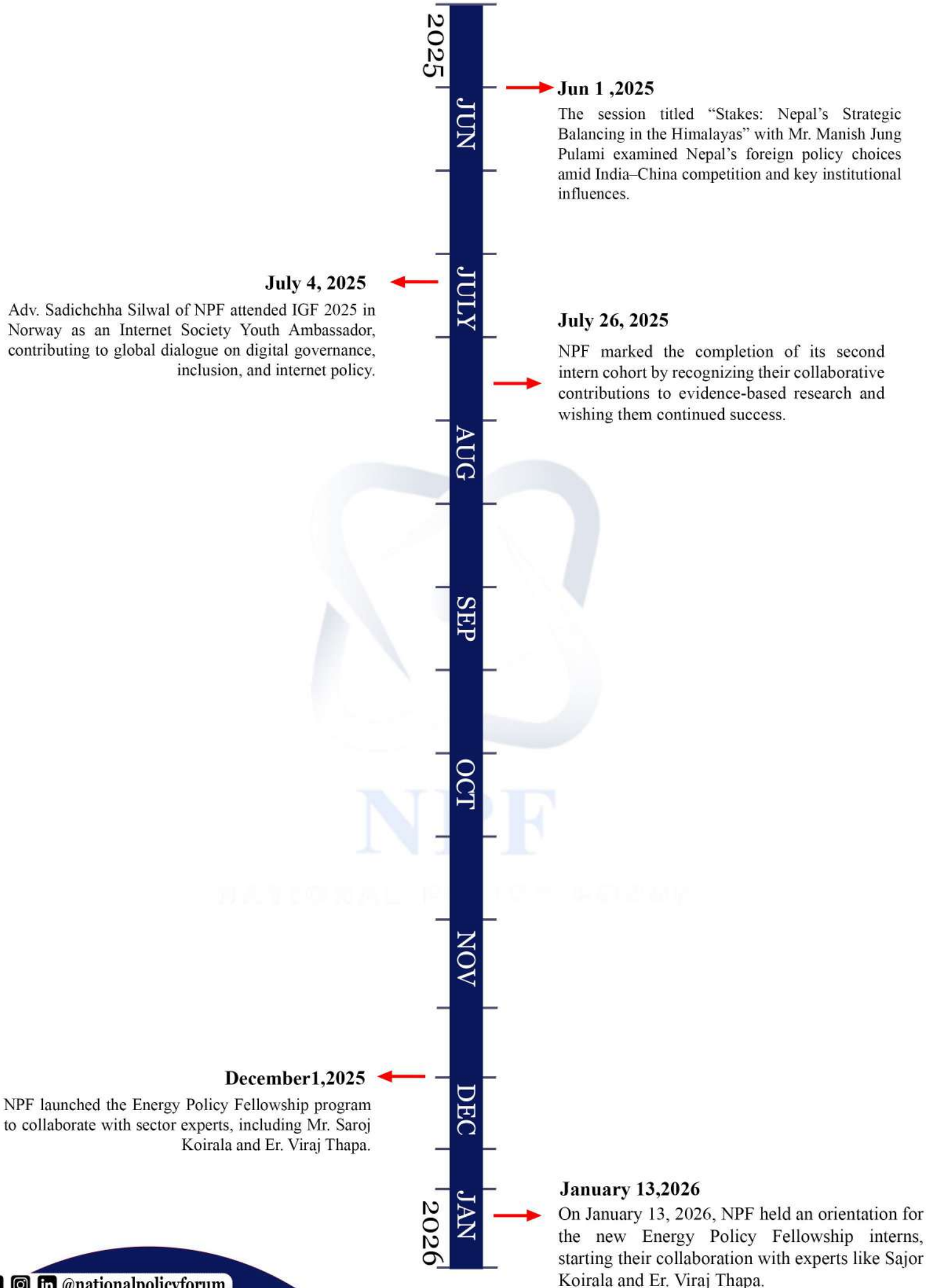

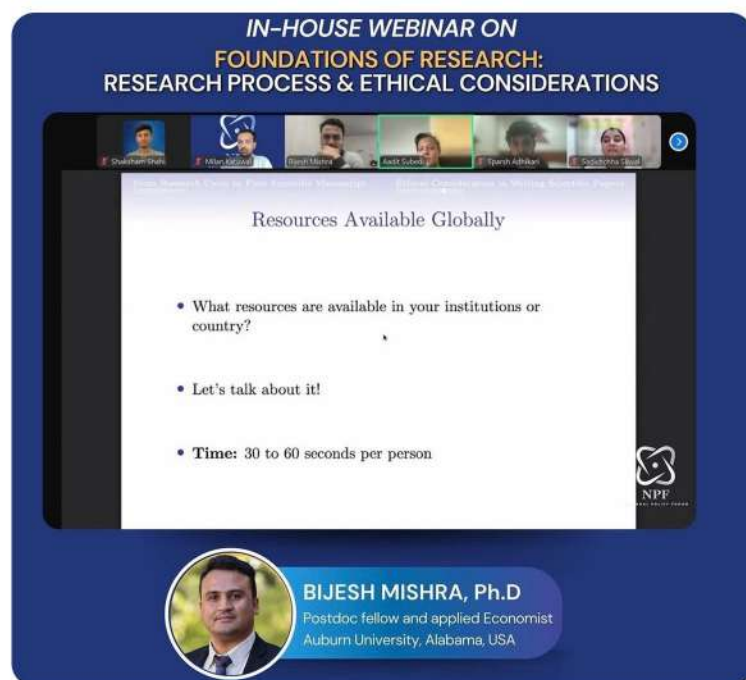
1. Internship Cohort-II “Orientation Ceremony Of New Batch Of Interns”

On 13th January 2026, NPF conducted an Orientation and On-boarding Session for the new batch of interns under the Energy Policy Fellowship.

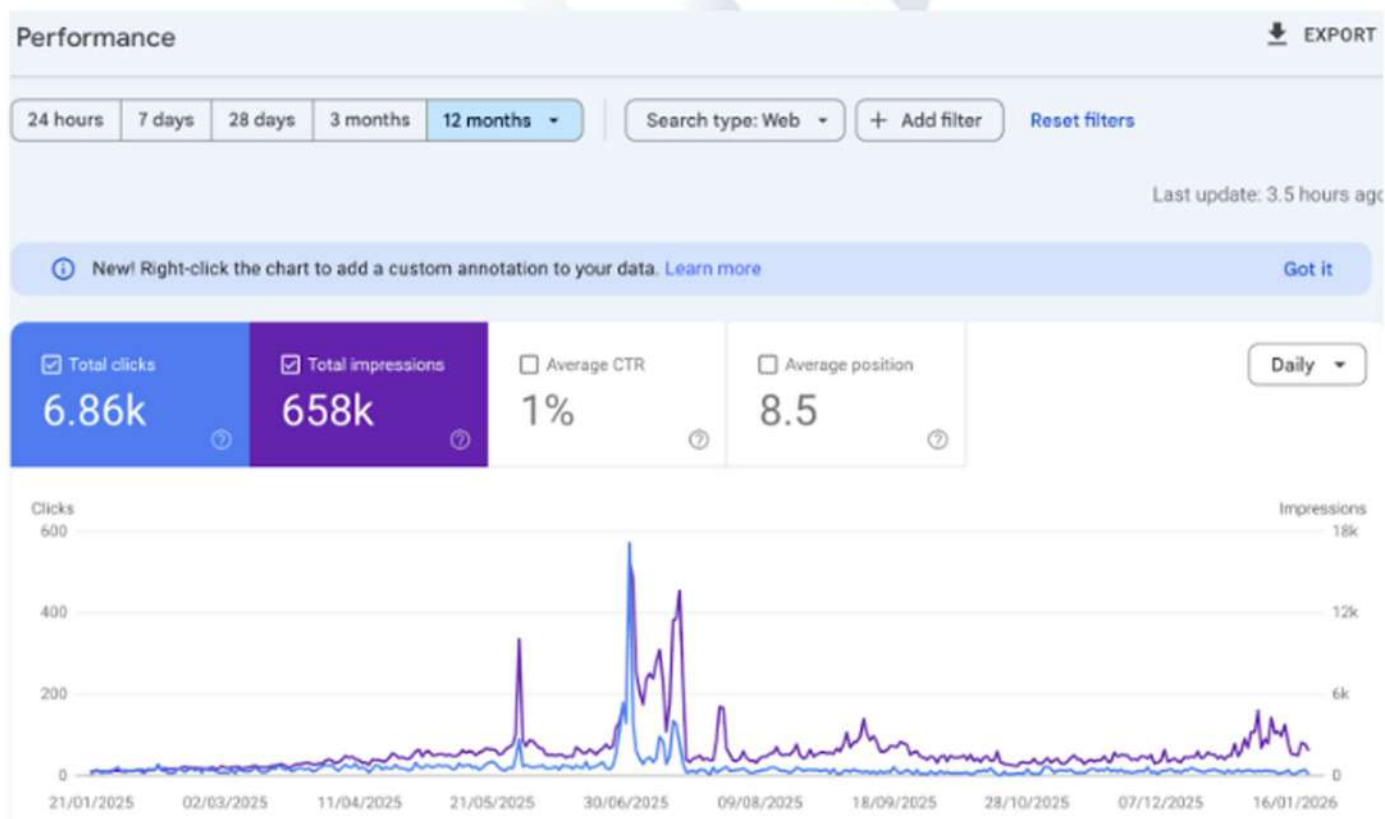

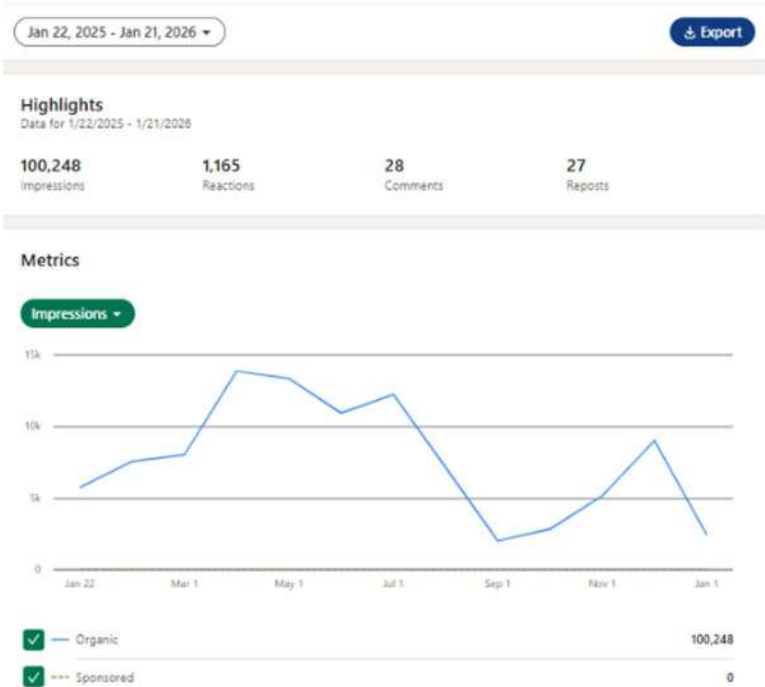

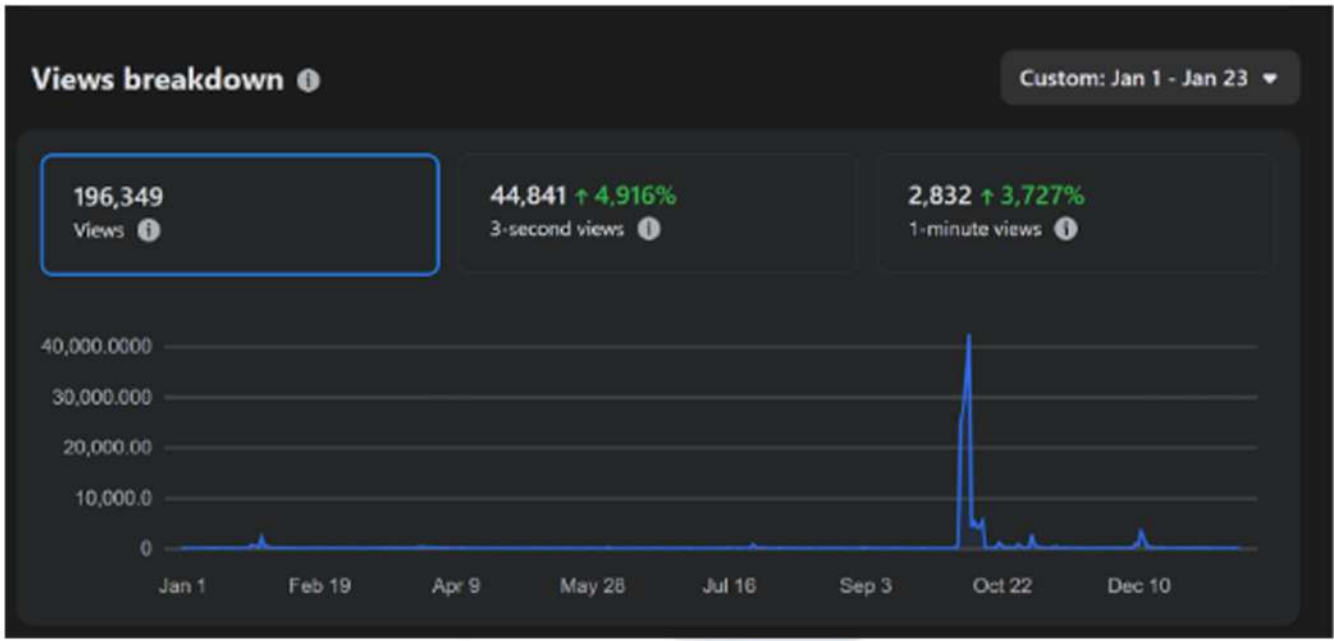
